- The HKILA maintains a list of HKILA Accredited Arborists for potential deployment to carry out tree assessment and supervise tree related works on site. Applicants for admission must possess the prescribed academic qualifications, professional qualifications and relevant experience, as specified below:

2. The personal data collected in this form will be used for assessing the application for admission to be a HKILA Accredited Arborist purpose only. Personal data of an unsuccessful applicant will normally be destroyed within 12 months after refusal of his/her application.
3. Applicants have to submit together with the application certified true copies of the original academic and professional certificate(s), and relevant proof of work experience. True copies of the academic and professional certificate(s) must be certified by the issuing authority or a recognized professional; and proof of work experience must be certified by a recognized professional.

Recognized professionals include:

i) Corporate / Professional Member of HKILA, HKIA, HKIS, HKIE, HKIP

ii) Accredited Arborist (HKILA)

4. Applicants also have to submit together with the application a “**Report on Training and Experience**” (the **Report**), with description on the applicants’ training and experience preceding the date of application. The Report has to include a short description (could be supported by photographic record) of a minimum of two projects/ cases, in which the applicant was involved. Extract of other assessment reports prepared by the applicant may also be included for better illustration of the applicant’s work experience. The Report should contain sufficient information demonstrating an applicant’s training and experience but should be presented in no more than 1,500 words, and no more than 8 A4 pages including all photographs and illustrations.
5. Relevant academic and profession qualifications and the “**Report on Training and Experience**” should also be submitted in the form of softcopies in CDROM / FTP.

6. Applicants must submit the stipulated application fee with the applications. Payment by cheque should be made payable to “**The Hong Kong Institute of Landscape Architects**”, OR by account transfer (ATM) to : The HK & Shanghai Banking Corporation (**bank code: 004 & account no. 033-211459-838**). Please write your name on the account transfer record and submit it together with the application form.
